# from the ceo

*Happy Spring...*

April is Child Abuse Prevention Month and we are busy with activities planned throughout the month. Our CAP-C (Child Abuse Prevention Collaborative) kicked off the month with a panel presentation on child abuse reminding all the child welfare and school professionals in the room about the short- and long-term effects of abuse and neglect and how important it is for them to continue their life-saving work to ensure the safety of our children. Our annual Light of Hope Celebration was Friday, April 4 at Sugar Land Town Square Plaza. This is our largest awareness event of the year where we showcase 20 different agencies in Fort Bend County providing services to children and families. We invited elected officials to join me on stage proclaiming our unified message that "We Are For The Child" with the background of Sugar Land City Hall lit up in blue, the national color of child abuse awareness. The significance of the blue ribbon is drawn from a story of a grandmother who was devastated to learn that her grandchild had died due to physical abuse. To bring attention to child abuse, she tied a blue ribbon to the antenna

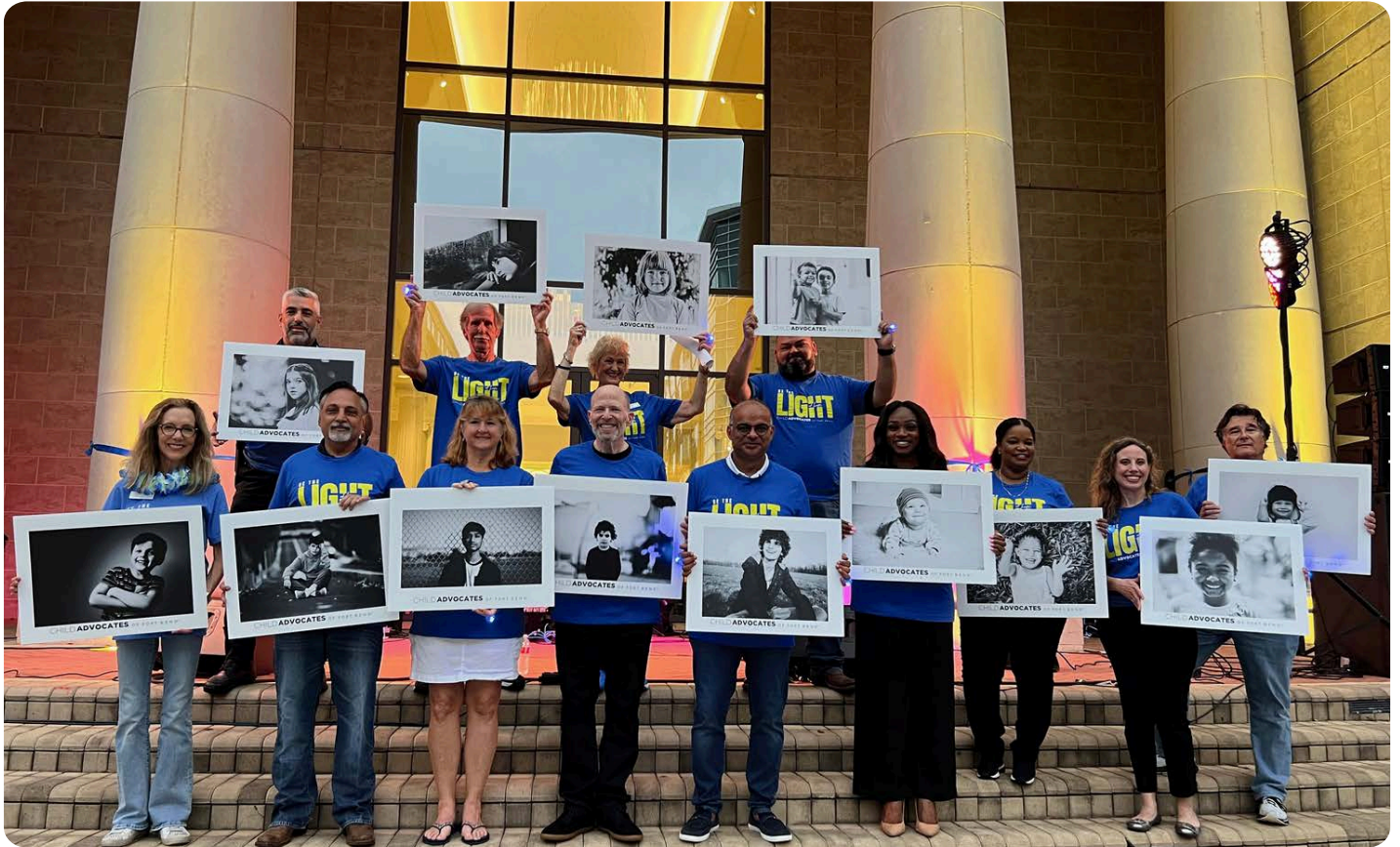
of her car to signify his bruised body. What began as a story of one little boy has now grown to be a national movement in honor of the hundreds of thousands of children who have suffered and died from their abuse. Later in the month on April 12, the Fort Bend County Sheriff's Office is hosting the Pinwheel Project which is a kid-friendly carnival at Traylor Stadium. We round out the month with our annual Gala For The Children on April 26 with the theme of "Inside Out" where we explore the many feelings that children experience in childhood and how important it is for adults to be aware and sensitive to these emotions. Come join us at these events and share your commitment to ensuring the safety of our children and the importance of strong families. Thank you for your support and all you do for children - as volunteers, donors, partners, ambassadors or staff. We are deeply grateful.

Children throughout our community experience abuse every day. We want to recognize the courage of each child that has come forward to tell. Child Advocates of Fort Bend is committed to bringing to light the issues of child abuse

and neglect. Our CEO, Ruthanne Mefford and community members provided messages of action, urged attendees to learn the signs, speak up when a situation doesn't look right, and report abuse.

We provided blue light-up rings to send a message that each one of us can do something and "be the light".

- **Invite us to speak:** Let community members and schools know about the child safety prevention programming that Child Advocates of Fort Bend provides.
- **Share resources:** Provide resources from our agency about how to talk to children about abuse and neglect.

Hello,

I just wanted to take the time to express my gratitude. It's been a long and tough few years for the kids especially. I am proud to be the mother of such brave and intelligent, beautiful children. **I know we have all had our ups and downs and disagreements and things did not end in the way I had hoped, but they did end well** and everything happens for a reason and in God's time.

I want to thank you all for the time and effort you put into my children and my case. I don't think this was easy for any of us. And things were definitely unfair to the children, however, **everything that has happened has led to an outcome that is far better than I originally planned or imagined.** That being that my family has reunited, I was afforded the opportunity to really work on myself and my recovery and other issues and grow into a better person and a better mother, a better sister, daughter and aunt. I have learned skills for parenting that, perhaps, I otherwise would not have.

My life is far more manageable now and **my support system is larger and stable.** Things are no longer happening to me back to back as they used to before and the way I am able to handle the stress and disappointments that do come, is completely different. My relationships are healthier, and I no longer struggle with the health problems I had struggled with previously. I have been given the opportunity to start over in a new place, not surrounded by harsh memories and unhealthy people and situations.

I am no longer alone. The kids are in such a great place and learning their roots and have the blessing of being back with both their mother and father, as well as their siblings and other family members. My family and I have grown and are no longer so dysfunctional and constantly bickering. I am sober, I am healthy and continue to heal. I now have a husband and we have our children again, and we are flourishing together.

I thank God every day for everything that happened. Though it was difficult and painful, and I wouldn't wish it upon anyone, it allowed us to grow and learn.

**Thank you for keeping me accountable, thank you for teaching me the skills that helped me to parent better.** Thank you for bringing the kids to this country. Thank you for the time and work you put into this. We are happy and I feel so much joy and hope for the future.

# Another Way CAFB Meets the Needs of Our Clients

Our mission has always been to meet patients and their families where they are, and one way we are doing that is by making medical forensic exams more accessible. We are proud to collaborate with TXFNE, providing both sexual and physical assault exams on-site. This partnership helps us achieve our goal of offering essential support when and where it is needed most.

## **On-Site Non-Acute Medical Forensic Exams**

Every Wednesday and Thursday, a nurse dedicated to the CAC is available to conduct on-site non-acute medical forensic exams. These exams are offered for cases where the assault or last known contact (for patients 13 and under) occurred more than 5 days prior. By providing these services on-site, we eliminate the need for families to travel to another facility, allowing them to receive care in a familiar, comfortable environment. If preferred by the patient and family, the exam can be scheduled on the same day as the Forensic Interview, helping to minimize the number of visits and making the process more convenient.

## **Coordinating Additional Support**

During the exam, if any additional needs arise for the patient or their family, our nurse will work closely with the family advocate to

connect them with any necessary services. Should the patient require additional medical care, TXFNE will ensure coordination with the appropriate medical resources.

## **Collaborating on Case Review**

Every other Thursday, a nurse from TXFNE attends the Case Review Team (CRT) to discuss the medical exams and address any questions or concerns. The nurse is also available to discuss any other medical questions that come up or if an exam would be appropriate in a case where the patient has not already received a medical forensic exam.

## **Acute Cases and After-Hours Care**

For acute cases or exams required outside of our regular Wednesday and Thursday hours, patients and families can visit St. Luke's Sugar Land or one of the Oak Bend facilities to receive an exam by one of TXFNE nurses. Their hotline and response are 24/7 and the number can be provided to the families so they can contact the nurse as well. TXFNE hotline is 281-306-6893 and they would press 1 for the nurse.

We remain committed to providing compassionate, timely, and accessible care for all families we serve.

# Justice-Involved Youth Pilot Program

For many years, CASA Advocates have served as valuable resources for children and families wrapped in the throes of the child welfare system, making a powerful impact. 2025 is bringing some exciting growth to the services provided by our CASA Program enabling us to expand our reach within our community. We have been given the wonderful opportunity to grow our impact as CASA by advocating for an additional extremely vulnerable population: Justice-Involved Youth (JIY).

Adolescents involved with the juvenile justice system need strong advocates to provide support, encouragement, guidance and advocacy. This is where CASA steps in. In partnership with Judge Teana Watson and Fort Bend County Juvenile Probation, Child Advocates of Fort Bend will begin implementation of the JIY Pilot Program in which CASA Advocates can be appointed to juvenile justice cases in need of extra support and advocacy.

The JIY Pilot Program aims to help these youth successfully complete probation, strengthen healthy family and community connections to prevent future involvement in the system, and increase educational engagement to promote academic success.

With the launch of the JIY Pilot Program, Child Advocates of Fort Bend is poised to make a significant difference in the lives of justice-involved youth. By providing these vulnerable adolescents with dedicated CASA Advocates, the JIY Pilot Program aims to empower them to navigate the complexities of the juvenile justice system, build brighter futures, and become thriving members of our community.



# Nest and WINGS Spring Break Event Recap

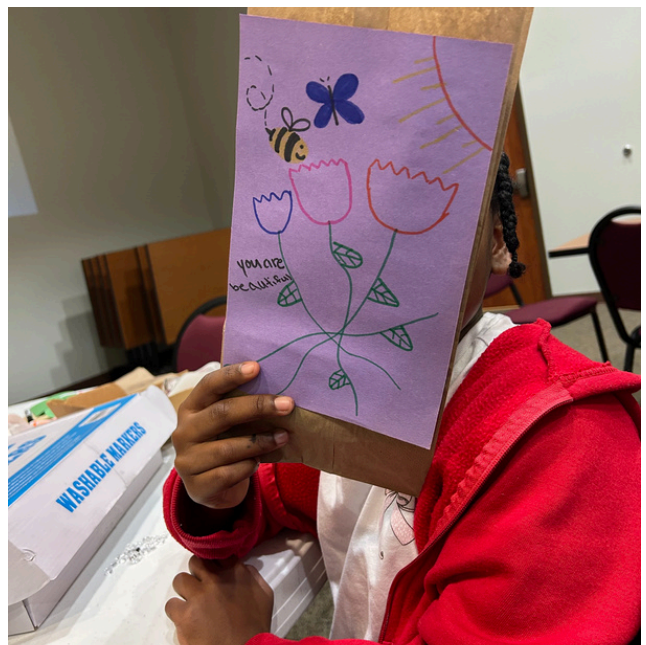

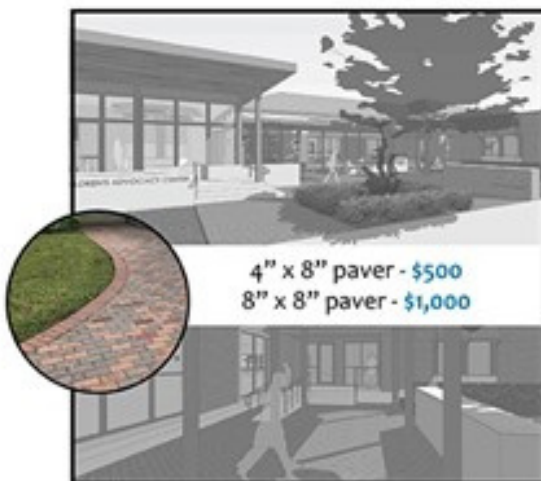

# CAFB Partners with Lamar CISD for Parent Education Series

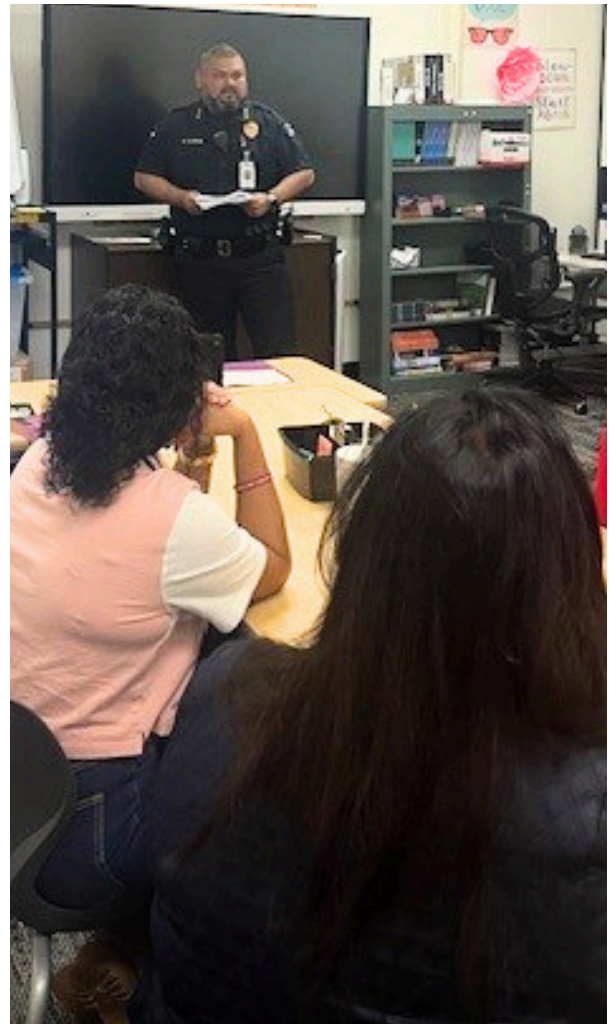

On March 6, 2025, Child Advocates of Fort Bend (CAFB) partnered with Lamar CISD's Project Learn to present an informative session for parents on "Recognizing and Responding to Child Abuse." This vital presentation, led by CAFB's Jheri Walters and Sandra Glenn, along with Chief Garcia of Lamar CISD, provided parents with essential knowledge on identifying signs of abuse and taking appropriate action to protect children.

As part of CAFB's ongoing mission to increase awareness and prevention efforts in the community, this session emphasized the importance of parental involvement in child safety. Attendees learned how to recognize various forms of abuse, understand reporting procedures, and create safe environments for their children. Chief Garcia offered a law enforcement perspective, addressing legal responsibilities, the role of school officials and parents in child protection, and the link between exploitation and social media. He discussed the dangers of online interactions, how predators target children through digital platforms, and preventive measures parents can take to safeguard their children.

This presentation was the first in a two-part series aimed at empowering parents with the tools and knowledge needed to safeguard children. The second session, held on March 27, focused on Internet Safety, providing insights on cyber threats, online exploitation, and digital well-being.

Their research and interventions are empowering parents, professionals, and students with trauma-informed strategies that improve outcomes for children and youth.*



### **Erin Merry**

*Erin is an internationally recognized author, speaker, and child abuse advocate and activist. For six years of her childhood she was sexually abused, keeping her secret locked away in her childhood diary. Before graduating high school Erin published her diary into a book called Stolen Innocence.*

*In 2013 she had Erin's Law passed in her home state of Illinois. The law requires personal body safety taught in public schools every year. She has made it her mission to have it passed in all 50 states. Currently Erin's Law is in 38 states, Kerala, India and Ontario, Canada.*

# Interfaith Gathering Recap

The Fort Bend County community is deeply interconnected, as evidenced by events like the recent Interfaith Gathering. This event highlighted the shared commitment across diverse faiths and values to protect our children and ensure community safety.

In March, we convened representatives from Christian, Islamic, Jewish, and Hindu congregations, along with community partners dedicated to supporting at-risk children and youth. The focus was to educate attendees about the critical issue of child abuse and explore collaborative actions to support children and youth in foster care and throughout our community. This valuable exchange fostered greater understanding of both needs and available resources in our area.

## Our partner agencies included:

- **ACHIEVE Fort Bend** - Supporting schools through an early intervention, drop prevention program.
- **Arrow Child and Family Ministries** - Providing services including foster care support, adoption, behavioral health services, transitional living services, medical needs support and more
- **CarePortal** - Care-sharing technology that drives action for local kids and families in crisis.
- **Child Abuse Prevention Collaborative (CAP-C)** - Launched by CAFB to unite 40 agencies in Fort Bend County to prevent and address child abuse.

- **Crime Stoppers of Houston** - Dedicated to solving and preventing serious crime in the Greater Houston Area in partnership with citizens, media and the criminal justice system. Calling to report a crime is always anonymous.
- **Fort Bend County Health and Human Services** - Promotes and protects the health and well-being of the residents of Fort Bend County through disease prevention and intervention, public health emergency preparedness and response, community engagement, and helping to assure the equitable provision of basic human needs.
- **The Sanctuary Foster Care Services** - Stops the cycle of multiple placements for children in CPS care by providing support, resources and assistance to foster care families in a variety of ways.
- **DFPS Faith-Based and Community Engagement** - The faith community has a long history of helping those in need. DFPS wants to partner with all faith communities in Texas to help vulnerable children, adults, and families.

Child Advocates of Fort Bend believes that collaboration is key to prevention and is proud to partner with numerous faith leaders and community organizations dedicated to improving children's lives.
